

AMERICAN ESKIMO DOG CLUB OF AMERICA, INC.

FUTURITY POLICY

Definition: A Futurity is much like a Puppy Sweepstakes, except that in order to compete, all American Eskimo Dogs must have gone through a nomination process. AKC Champions of Record are eligible to compete in Futurity provided that they meet all other eligibility requirements. There are no handler restrictions.

Classes: The following Classes will be provided for both dogs and bitches:

- 6 Months and Under 9 Months
- 9 Months and Under 12 Months
- 12 Months & Older

Nomination Process

1. Litter Nomination

The Futurity Application may be mailed to the Futurity Registrar by eight (8) weeks of the mating along with a check in the amount of ten (\$10.00) dollars.

A deferred breeding nomination will be accepted for a litter up until the age of twelve (12) weeks after birth for a fee of fifty (\$50.00) dollars. A copy of the completed and signed AKC litter registration must accompany a nomination submitted under the deferred plan and the nomination must be postmarked within the submission deadline of twelve (12) weeks of age.

2. Individual Puppy Re-Nomination

The individual puppies in the litter must be re-nominated after birth. The Individual Puppy Re-Nomination must be postmarked by twelve (12) weeks of birth and sent to the Futurity Registrar along with a \$10 fee for each individual puppy nominated. The individual puppy must be entered in the AEDCA Futurity for the year that it is eligible. The Show Secretary must receive the entry prior to the closing date for the National Specialty Show along with the required entry fee.

Prize Money

The nomination and entry fees for each class, divided by sex, of the Futurity will be combined into one pool and awarded based on entries for that class. Prize money for each class will be divided as follows:

Retained by the Club	30%
Contribution to Best in Futurity	10%
First Place	30%
Second Place	15%
Third Place	10%
Fourth Place	5%

The six winners of each class will compete for Best in Futurity (BIF) and Best of Opposite Sex to Best in Futurity (BOS/BIF). The pooled contribution for BIF from each of the six classes will be split between the BIF (60% of BIF pool) and BOS/BIF (40% of BIF pool).

Please make check or money order (NOT CASH) payable to AEDCA.

Applications will only be accepted for litters nominated by twelve (12) weeks after date of birth.

Re-nomination of a puppy will only be accepted when the re-nomination is postmarked 12 weeks or less after the puppy's date of birth.

If the litter nomination is made eight (8) weeks or more after birth, the following individual puppy re-nomination form should be sent in at the same time as the litter nomination. Before eight (8) weeks of age, only the litter nomination is required - you will receive a puppy re-nomination form from the Futurity Registrar.
